## NON-REGULAR CONFORMATION CLASSES

**Veteran Classes:** Classes for Dogs & Bitches 8 years old & under 10 years old, 10 years old & under 12 years old and 12 years old & older. Sexes divided.

**Hunting Retriever Class:** For any dog or bitch that has earned a Junior, Senior or Master Hunter title under AKC rules.

**Stud Dog Class:** For stud dogs and 2 of their Get. Stud dogs entered in the Stud Dog Class must be shown in the ring with their Get. Only the Get will be judged, based on the merits of the Get. The Get MUST be entered in one of the Regular, Non-Regular or Best of Breed Classes. The Stud Dog and the Veteran Dog may be neutered if it is the only class entered. The Stud Dog shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class if Stud Dog is entered in another class.

**Brood Bitch Class:** For brood bitches and 2 of their Produce. Brood bitches entered in the Brood bitch Class must be shown in the ring with their Produce. Only the Produce will be judged, based on the merits of the Produce. The Produce MUST be entered in one of the Regular, Non-Regular or Best of Breed Classes. The Brood bitch and the Veteran Bitch may be spayed if it is the only class entered. The Brood bitch shall be considered as one entry and requires one entry fee, this being the regular fee plus the additional class if Brood bitch is entered in another class.

## SWEEPSTAKES & VETERAN SWEEPSTAKES CLASSES

The Show Site will be available to exhibitors at 5:00 pm Friday, May 30, 2008.

- Choke collars, pinch collars, prong collars, electric and dummy electric collars are prohibited on show grounds.
- AGRC and Triple Crown Dog Academy assume no responsibility for any loss, damage or injury sustained by exhibitors, handlers or to any of their dogs or property and further assumes no responsibility for injury to children.
- Exhibitors are responsible for picking up after their own dogs. A clearly marked doggy bathroom area will be located outside at the back of the events building.
- No smoking inside the events building.
- Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate vaccinations.

Dogs must be ready for judging. Neither the club nor its Secretary will be responsible or obligated to furnish any service for notifying exhibitors or their agents of Breed or Class Judging. Judges need not wait for any dog holding up a class. **Owners or agents alone are responsible for the presence of their dogs in the judging rings.**

There will be no refund for duplicate entries. However, care will be taken to find duplicates before processing. Owners are responsible for errors in making out entry forms and no entry fee will be refunded in the event of such errors. Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Show Committee.

No entry fee will be refunded if the Show cannot open or be completed by reason of extreme weather conditions, riots, civil disturbances, fire, an act of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.

Exhibitors are responsible for complete, accurate, and legible information on their entry forms; illegible or incomplete entries cannot be entered in the show. **IF THE ENTRY FORM IS PHOTOCOPIED OR FAXED, THE AGREEMENT ON THE BACK OF THE FORM MUST ALSO BE PHOTOCOPIED OR FAXED AND ATTACHED TO THE ENTRY WHEN IT IS MAILED OR FAXED.** Unsigned Entry Forms cannot be accepted or entries which specify any conditions as to its acceptance. Checks that have been returned due to insufficient funds do not constitute a valid entry and will have a \$25.00 service charge attached.
